Registration: All entries must be received by 5:00 p.m. on Friday, October 14, 2022. Drop off forms at the office of University Advancement in Inlow 212 or email alumni@eou.edu.

Line-up: Check in/Line-up will begin at 4:00 p.m. at the corner of Hemlock Street and Washington Ave.

Parade Rules: The parade begins at 5:00 p.m. Vehicles, floats, etc. will line up on Hemlock St. & Washington (facing south) and will proceed west on Adams Ave. The parade will end by turning right on Fourth Street, disassembling vehicles on Fourth and Jefferson. No political campaigning is permitted. Candy, balloons, handouts, etc. may be handed out. **City ordinance states that items must be handed out by persons walking on either side of the vehicle, float, etc., they may NOT be thrown from vehicles.**
