

Constitution of the EOU Trapshooting Club

Article 1: Name

The name of this organization shall be the EOU Trapshooting Club.

Article 2: Purpose

To educate all interested students in the proper technique of the sport of trapshooting, as well as teaching the safe handling of a firearm. Also to create a sense of community throughout the members honoring Eastern's culture and values that this club represents.

Article 3: Membership

All students participating in the EOU Trapshooting Club shall pay the yearly \$25 membership fee regardless of credit hours being taken or completed shall comprise of the club memberships. Student wanting to come out and try trapshooting are not required to pay the fee unless they participate more than once a term.

Article 4: Organization

- Where Powers Vested. Except as this constitution otherwise provides, all powers of the EOU Trapshooting Club shall be vested in its members and advisors. The members shall adhere to, create, or modify the constitution to carry out its core mission.
- All decisions of the EOU Trapshooting Club will be voted on by the members and be implemented if passed with of 2/3 majority vote.

Article 5: Officers

The EOU Trapshooting Club officer team will be comprised of the following:

- The President:
 - The President shall serve a term of one academic year. The EOU Trapshooting Club President-Elect shall serve a term that begins on the last Friday of the spring term after the appointment of position and ends on the last Thursday of the spring term in the following year. The EOU Trapshooting Club President shall preside over all club meetings. The President shall vote in the meeting only in cases when it is necessary to determine the passage of legislation. The EOU Trap Club President cannot vote in cases that involve presidential veto override legislation.
- Director of Publicity and Communication:
 - The Director of Publicity and Communication will serve as the co-chair of all meetings.
 - They will be in charge of managing all social media accounts, as well keeping in contact with Administrative departments of EOU, student groups, and various groups in the community.
 - They will be in charge of notifying all members and advisors of official and unofficial meetings and other updates.
- Director of Event Management
 - The Director of Event Management will work directly with the club President for coordinating with all members to organize events, shoots, and details for club trips and delegating tasks.
- The Treasurer:
 - The Treasurer will be responsible for tracking and reconciling all club funds as well as assist in planning/budgeting for all club funded trips. The Treasurer will report the balance as well as all transactions to the club quarterly. The Treasurer will work with Club Advisors and Center for Student Involvement to produce club financial reports. The Treasurer will be in charge of writing senate allocations requests, vending committee requests and assist with grants for the club.
- Secretary/ Safety Officer

- The Secretary will be responsible for taking minutes at all official meetings. They will also assist the Director of Publicity in their activities. They will send minutes to all members of the club.
- As the Safety Office they will be in charge of delegating weekly duties at the gun club.

All positions will be subject to step in and help other positions as needed.

Article 6: Elections

Elections will be held at the end of spring term. All open positions will be advertised to campus via social media, and through CSI for a week before elections occur. All positions will be voted on via secret ballot by all EOU Trapshooting Club members and will be reviewed by a third party. Only official members of the EOU Trapshooting Club can vote.

In the case where an elected official does not return to school the next year, the existing club leadership will appoint a club member for that vacant position.

Article 7: Meetings

An EOU Trapshooting Club meeting will be held quarterly. The officer team will meet the every month. At least 2/3 of members must be present in order to hold an official meeting or an official vote.

Article 8: Statement of Non-Discrimination

The practices and policies of the EOU Trapshooting Club shall not:

- Exclude, expel, or limit membership because of an individual's race, color, creed, ethnicity, religion, age, sex, gender, sexual orientation, national origin, socioeconomic status, disability, gender identity, expression, or status as a veteran.
- Exclude from being hired, elected, appointed, or otherwise discriminated against any individual with respect to their compensation, terms, conditions, or privileges of employment, because of such individual's race, color, creed, ethnicity, religion, age, sex, sexual orientation, gender identity, expression, national origin, socioeconomic status, disability, or status as a veteran.
