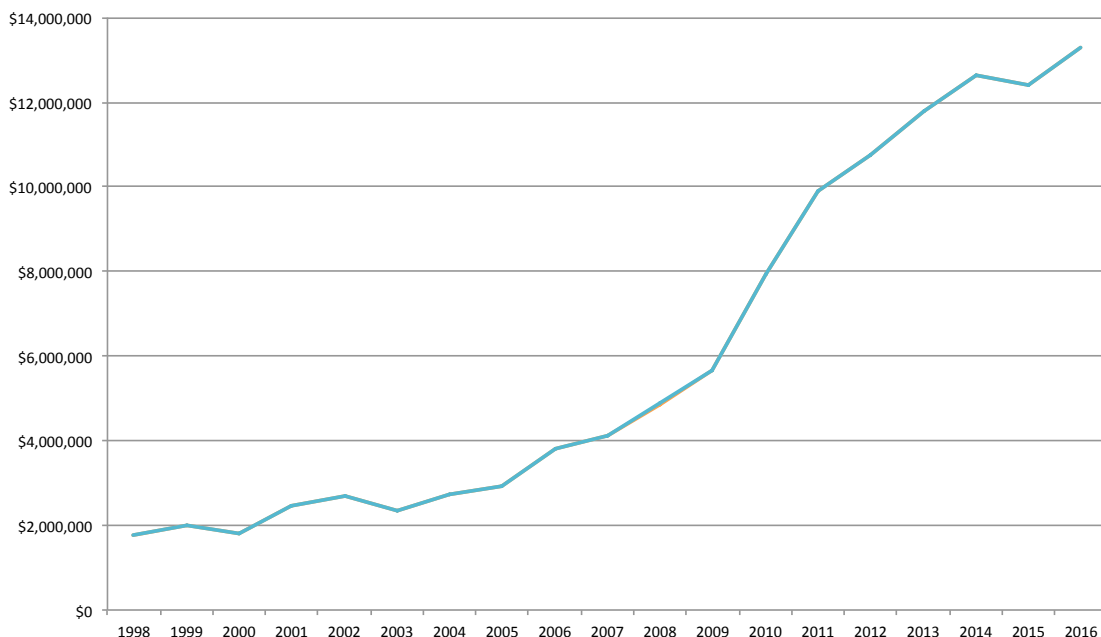

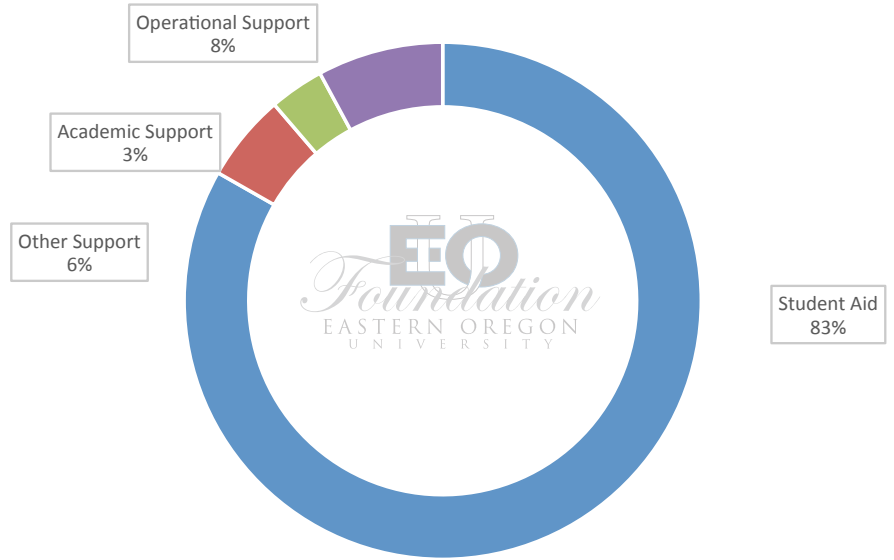

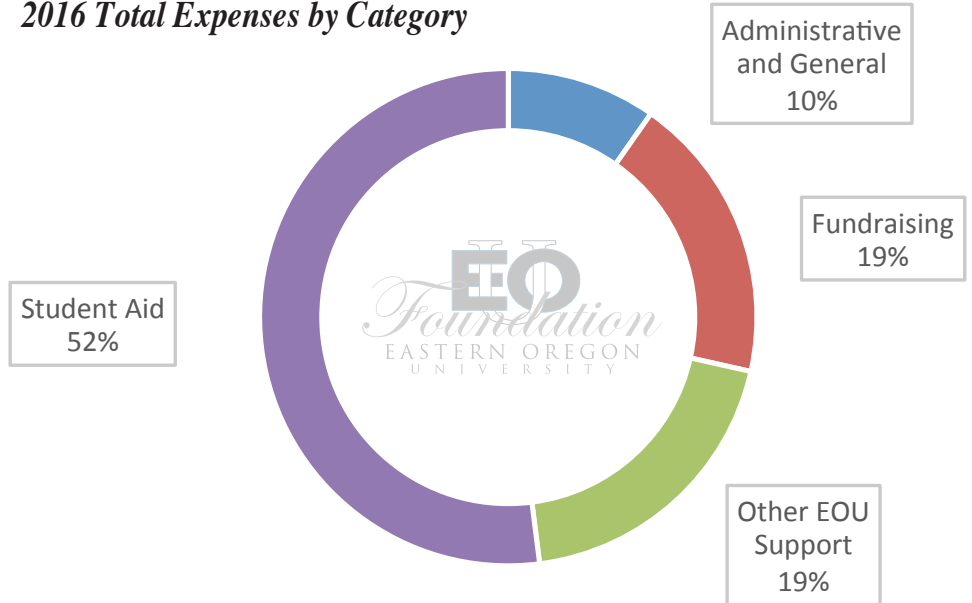

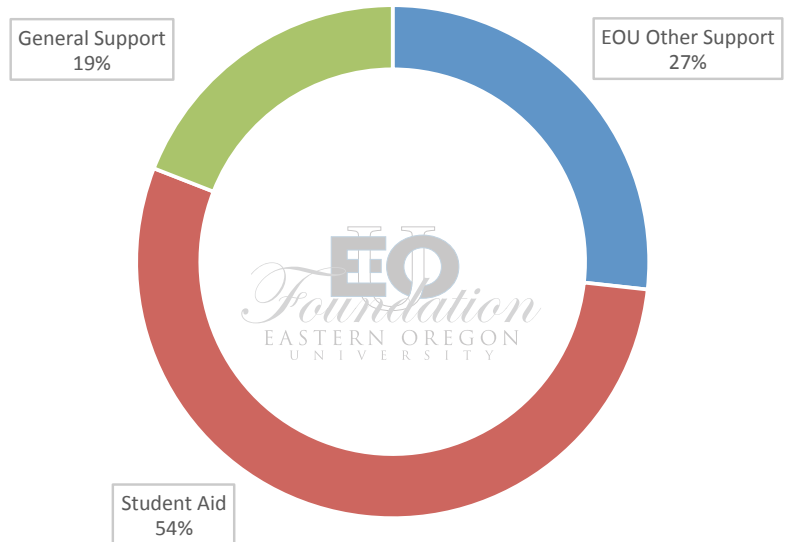
2016 Total Assets by Category
